  - C. Boyd asked how the Board can support her recruitment and enrollment efforts and she answered that we need to invest more into the website and spread the word about who we are.
  - Jasson read mentioned that she took her time to sit down with all of the parents to guide them in the application process

### Mission, Vision, and Portrait of a Graduate

- Mark explained the LAPCS Mission/Vision rework and Portrait of a Graduate. Further explained to the Board how the community contributed (leadership, staff, and scholars) to both.
  - V. Ramos thanked the leadership team for developing the mission/vision from a community perspective and asked if these were core values.
  - A. Ferg replied that it was not necessarily the case, but that this is a conversation we can have.
  - A. Lopez asked if it would be used in the school or recruitment and if they will be posted.
  - M. Simms answered "yes" to all of the above and added that these were not force-fed. This was a collaboration and this is what should drive our work and parents should know that these are the things that we are going to impress upon scholars.
  - A. Ferg further explained the unveiling would be at the 25th Anniversary Gala and we would then have the graphics printed and it would be part of the branding.
  - Board members then offered feedback, such as rewording, adding the Portrait of Graduate as values, and that the Board should vote on them.
