- Scholar Enrollment for 2023-2024 (J. Read):
  - Registration Opened 06/12/2023
    - 52 Registered
    - 22 seats remain for 2023-2024
    - 9th grade 100% full
  - Waiting list 15 scholars
  - o 7th & 10th also full
- Academics (A. Ferg)
  - Ended 2022-2023 with 204 scholars
  - Summer School started June 7
    - 24 scholars required to attend
  - 3 scholars retained
    - HS scholars not meeting credit requirements
  - A. Ferg reviewed the PSSA scores
